## Membership Terms and Conditions

### Membership Period

The membership contract periods are as follows:

- 3 month contracted membership then rolling month

### Membership Hold

During your membership, you are able to place the membership on hold.

All hold requests must be submitted online, and emailed to [essence@essenceofliving.com.au](mailto:essence@essenceofliving.com.au), or at the studio, by completing and submitting the membership hold form.

### Hold Policy

For all membership holds, we require a minimum of two week's written notice, prior to the hold taking place. One hold can be a maximum of one month, and a minimum of one week in duration. Holds must be applied in weekly blocks (7 days). The amount of holds available for each membership is as follows:

- 3 month rolling membership: up to 1 hold every 4 months

Once your hold request has been submitted, a representative of Essence of Living will contact you with a confirmation that the hold has been applied and provide you with the dates of the effective period. As you are on an Ezi Debit payment plan, your payments will be suspended during the entirety of your hold period, and will resume upon the conclusion of the hold period.

### Minimum Commitment and Cancellation Policy

All memberships require at least 2 weeks notice prior to cancellation. The minimum commitment to each membership before they can be cancelled is as follows:

- 3 month rolling membership: minimum 3 month commitment

Memberships cannot be cancelled while on hold.

Memberships are non-transferable. No refunds or exceptions.

### Payment Policy

Payment through Ezi Debit can only be made via direct deposit, from your bank account. If you default on a payment, a \$20 missed payment penalty fee applies for each missed payment. This does not include any payment default charges applied by Ezi Debit.
